3. **Appointment of chair and vice-chair of the PhD committee** (recommendation to the Dean)

PhD programme chair Christoffer Green-Pedersen (PS) was elected in absentia as chair and PhD student Julianne Moelmann (MGMT) was elected as vicechair of the PhD committee. A recommendation on the composition of the PhD committee has been send to the Dean (*awaits approval, ref.*). Due to the absence of the chair of the PhD committee HSN continued to lead the meeting.

4. Approval of observer

Simon Fuglsang (Observer, SOCSCIBUS) and Kristoffer Holm (Observer, BTECH) where both approved as observers.

5. **Short briefing about the current covid-19 situation** by Niels Mejlgaard A short briefing on the current status for exemptions and extensions was given by NM. Requests for either extensions or exemptions regarding research environment change stays are continuously coming in and are still handled individually case by case. Currently, 40 applications for extension of enrolment and employment has been received; 5 are in process, 24 has been fully or partially granted and 11 has been rejected. This amounts to app. 45 months extension, in the range from 14 days to four months. The PhD school administration has not received any new applications for dispensation from 30 ECTS since the summer of 2020. A total of 80 dispensations for research environment change has been granted. In case of research environment change, all dispensations contained either a suggestion for a stay in Denmark or some sort of virtual element. (Data per 21 January 2022, ref.)

The briefing was noted.

6. The Head of the PhD School's authority to approve PhD courses and merit applications until 31 January 2023 as well as the authority to recommend assessment committees to the Dean until 31 January 2023

The PhD Committee delegated the competence to approve PhD courses and merit applications, as well as the authority to recommend dissertation assessment committees to the Dean, to the PhD School Head. This has been the practice since the formation of the PhD school at Aarhus BSS. If the PhD committee gives the PhD School Head this authority, the PhD committee will be informed about approved courses, merit applications and appointed assessment committees in connection with ordinary meetings. The decisions made by the PhD school Head will be based on agreements made by the PhD committee, but the decision process will be more efficient.

7. Follow-up plan for the survey "Quality in the PhD Process" (KIP21) and the international evaluation of the Graduate School by Niels Mejlgaard Page 2/4



The KIP21 survey and the international evaluation of the Graduate School were both processed in 2021. As they point to several of the same issues, it makes sense to do a joint follow-up.

The following plan was proposed:

- January-beginning of Marts: small meetings between the PhD school head and an administrative representative with the below parties. The meetings are meant to make sure all relevant topics and possible suggestions for solutions are brought forward.

- end Marts: a meeting in connection with the next PhD committee meeting where a final follow-up plan must be decided upon.

The proposed follow-up plan was approved.

HSN noted that there is a high number of PhD students on sickness leave, and that this is a point of observation that will be part of the follow-up on KIP21 and the international evaluation of the Graduate School.

The briefing on assessment committees appointed for the period from 1 November 2021 to 10 January 2022 was noted. It was commented that the gender balance is usually a point of observation, but in this case where very few assessment committees has been appointed this can not be considered as representative.
