## 1. Approval of agenda

# 2. Briefing on the current situation at Aarhus BSS Graduate School due to COVID-19 by Per Baltzer Overgaard

The current COVID-19 situation was discussed and it was announced that a general AU FAQ for PhD related questions is coming as soon as possible (*is now available here: https://medarbejdere.au.dk/en/corona/for-phd-stu-dents/, ref.*). The overall answer to questions in the FAQ is as follows: contact your supervisor and discuss how to work around the situation. If no work around is possible, the matter should be brought before the Head of Aarhus BSS Graduate School as per usual. The COVID-19 situation in itself is not enough argumentation.

**3. Briefing on the enrolment and recruitment of PhD students follow***ing the round of applications in spring 2020* by Per Baltzer Overgaard The original plan for the current application round has been followed in spite of the current COVID-19 situation and a record number of applicants in this round. A total of 481 applications were received for the spring of 2020 open call, and 88 applicants were assessed as qualified. 31 candidates are recommended for enrolment with grants, distributed as follows: ECON (8), LAW (5), MGMT (5), PS (4), PSY (4), BTECH (3), SOCSCIBUS (2). Of these 28, 5 is expected to be financed by the graduate school. Furthermore, one candidate was recommended for enrolment at the spring 2020 special call, 100% external financing.







**Minutes** 



Through a longer period of time, the number of active PhD students enrolled at the graduate school were 50/50 male/female. This was not the case in the autumn 2018 and spring 2019 application rounds. In the last application round the ratio was again 50/50 male/female. Of the recommended candidates in the current application round, 18 were male and 14 female. This will continue to be a point of attention in the coming application rounds.

Approximately 1/3 are international candidates and all of the candidates will be enrolled as per 1 September 2020.

In this application round 5 candidates will be enrolled in the 4+4 scheme.

The briefing on enrolment and recruitment in spring 2020 was noted.

Between January and Marts 2020 two courses has been approved: PhD course on Political Behavior (PS, 5 ECTS), and Directed Search and Asset Markets (ECON, 2 ECTS).

PS explained upon request the setup of their course where PhD students, as experts in their field, teach other PhD students. A VIP is always present at the sessions and has the responsibility of the sessions academic quality and level. Furthermore, a VIP is overall responsible for the course.

It was commented that the course from ECON has been postponed due to the COVID-19 situation, as it was supposed to take place in April.
